

## **PRIVACY POLICY**

Statim Corp. (“We” or “Us”), the owner of the website [www.statim.com](http://www.statim.com) (the “Site”), respects the privacy of everyone who uses our Site and portion of our Platform (“you” or “Users”). This Privacy Policy explains how we collect, process, and store your personal information when you visit or use our Site, our mobile application for iOS and Android devices (“App”) and any content, functionality and services offered on or through the Site (“Services”) (Site, Services, and App, are collectively referred to herein as (the “Platform”).

### **Introduction**

We provide access to a market place that connects placement agencies and legal support services (the "Service"). By using or otherwise accessing or using any of the Site, App, Service or other portion of the Platform, you acknowledge that you accept the practices and policies outlined in this Privacy Policy. Your use of the Platform, and any dispute over privacy, is subject to this Privacy Policy, our Terms of Service available at <https://www.statim.com/terms-of-service/> (“TOS”). The TOS are incorporated by reference into this Privacy Policy. If you do not agree to this Privacy Policy or the Terms of Service, please do not visit or use the Platform.

We may revise and change this policy and the ways in which we collect, use and disclose personal information. Please check back here frequently to review the latest version of this policy.

## 1. What Information We Collect About You

The information we may collect about you is described in this section, and includes data related to your account registration, payment and security, such as your name, email address and credit card information, telephone number and address, as well as information you provide us with voluntarily (collectively, the “Personal Information”). We may collect Personal Information directly from you, from third parties, or automatically through your use of the Platform.

### ***Information We Collect Directly.***

- If you wish to use the Service to locate legal support services or offer your legal support services, we first require you register for an account and provide us with your name, email address and telephone phone number.
- Should you choose to directly contact us via email or chat, we will collect your name and any contact information you may provide us with.

### ***Information We Collect Automatically.***

We automatically collect analytic information related to how users use the Platform on an aggregate and anonymous basis. We may use Google Analytics to collect this information.

### ***Information We Collect Passively.***

- We use cookies and other tracking mechanisms to do such things as track information about your use of the Platform on an aggregate and anonymous basis so that we may recognize you and your device and improve the Platform. We automatically collect information regarding the actions you take on the Site (“Usage Data”). For example, each time you use the Site we automatically collect the type of Web browser you use, your operating system, your Internet Service Provider, your IP address, the pages you view, the websites you visit before and after visiting the Site, and the time and duration of your visits to the Site. We use this information to help us understand how people use the Platforms, and to enhance the services we offer. We also collect device-specific information (such as your unique device identifiers). We may associate your device identifiers with your account.
- ***Cookies in General.*** A cookie is a small amount of data, which often includes an anonymous unique identifier, which is sent to your computer or mobile device from the Platform and is stored in your computer or mobile device. For instance, cookies help us understand your preferences based on your previous or current activity on our Platform, which enables us to provide you with a better customer service experience. We also use

cookies to help us compile aggregate data about our website's traffic and interaction with the Platform so that we can offer better experiences and tools in the future. You can choose to have your computer or device warn you each time a cookie is being sent, or you can choose to turn off all cookies. If you turn off all cookies, some features of the Platform will be disabled, and as such, your experience with the Platform may be impacted.

- **Third-Party Cookies.** We contract with third party analytics services such as Google Analytics, Flurry and TV Page on the Platforms to collect Usage Data, to analyze how users use the Platforms, and to provide advertisements to you on other websites. ## 2. How We Use The Information We Collect

We use the Personal Information we gather about you for any or all of the following reasons:

- To provide the Platform; to communicate with you about the Platform or changes to the TOS, this Privacy Policy; to respond to inquiries; and for other customer support purposes.
- To personalize and customize the Platform to better suit your preferences, to offer personalized help and instructions, and to otherwise improve your experiences with the Platform.
- For marketing and promotional purposes. We may collect Personal Information about you to send you special offers and promotions, or to otherwise contact you about products or information we think may be of interest. You may opt out of these offers and promotions by emailing us at the email address listed below. We will never sell your Personal Information to third parties.
- To improve the Platform.

## 3. How We Share Your Information

We may disclose the Personal Information that it collects in the ways described above, and to comply with the law, and to protect us and other users of the Platform. For example, we may share information with:

- **Third-Party Providers.** To help run the Platform, we may disclose the Personal Information we collect from you to third-party vendors, service providers, contractors, or agents.
- **Business Mergers; Other Transfers.** If we are bought out by or merged with another company, or we are involved in a bankruptcy proceeding, or in the event of a transfer of some or all of our assets we may transfer the Personal Information we have collected from you to the other company. We may share Personal Information [and Usage Data]

with businesses controlling, controlled by, or under common control with our Statim Corp.

- ***In Response to Legal Process.*** We may disclose the Personal Information we collect from you in order to comply with the law, a judicial proceeding, court order, or other legal process.
- ***To Protect Us and Others.*** We reserve the right to disclose Personal Information gathered from you if we believe it is necessary or appropriate to investigate, prevent, or take action regarding illegal, unethical or legally actionable activities, suspected fraud, situations involving potential threats to the safety or property of any person, violations of the TOS, this Privacy Policy, or any Additional Agreements, or in the course of litigation which we are a party.
- ***Aggregate and De-Identified Information.*** We reserve the right to share aggregate or de-identified information about its users with third parties for marketing, advertising, research, product development or similar purposes.

#### 4. How We Protect Your Information

We want to make sure that your Personal Information is properly protected. We implement a variety of security measures to protect your Personal Information. However, please be aware that despite our best efforts, no data security measures can guarantee 100% security. You must take steps to protect against unauthorized access to your password, phone, and computer by, among other things, keeping your username and password private. You agree that we are not responsible for lost, stolen, or compromised passwords or for any activity via unauthorized username or password activity.

By using the Site or the Services you may make parts of your Personal Information visible and available to others. For example, when you post a comment or a photo on the Site other users may see your name (first name and last name initial), the city you live in and other information that you choose to make available to others.

#### 5. Third-Parties

We may use several third-party services and applications to help run the Platform, evaluate usage of the Platform, improve the Platform, and customize user experiences. These entities may use cookies and Personal Information shared in the manner described in their own Privacy Policy to perform their services. These third parties include software developers to improve and run the Platforms, secure credit card and e-commerce processing, account analytics, and storage and security companies. For example, we use PayPal to process your credit card transaction when you purchase something from the Site.

#### 6. Third-Party Links

The Site may contain links to third-party websites and/or applications (the “Third-Party Links”). Any access to and use of such Third-Party Links is not governed by this Privacy Policy, but instead is governed by the privacy policies of those Third-Party Links. We are not responsible for the information practices of such Third-Party Links.

## 7. User Content

If you post content using the Platform, all of the information that you post will be made available to the public. We cannot prevent such information from being used in a manner that may violate this Privacy Policy, the law, or your personal privacy. As a result, you should never post any sensitive information using the Site and the Service that you are not comfortable sharing with the public. We are not liable to you or any other person for any content or information you post using the Site and the Service, or the use or disclosure of such content or information by other users or third parties.

## 8. Fair Information Practices Compliance

If a breach of data occurs with our Platform, we will notify you via email to the email address associated with your account within thirty (30) business days of discovering the breach. You agree and specifically consent that we may send you these notices, and other legal notices, via email. If you do not wish to receive these notices via email, please contact us at the telephone or email address listed below and let us know that you wish to receive these notifications by mail.

## 9. Access to Your Personal Information

You may modify the Personal Information that you have submitted by logging into your account and updating your information. You can also call us at the number listed below, or email us at the address listed below, and we will assist you with modifying and/or accessing your Personal Information.

## 10. Notice to California Residents/Your California Privacy Rights

## 11. Processing in the United States and Other Countries

Please be aware that your Personal Information and communications may be transferred to and maintained on servers or databases located outside your state, province, or country. If you are located outside of the United States, please be advised that we process and store information both in the United States and in other countries. The laws in the United States or other countries may not be as protective of your privacy as those in your location. By using the Site or Services, you are agreeing to the collection, use, transfer, and disclosure of your Personal Information and communications will be governed by the applicable laws in the United States.

## 12. Do Not Track Signals and Minors

We do not respond to Do Not Track Signals.

The Platform is for those over the age of 18. We do not knowingly collect or solicit any information from anyone under the age of 13.
